## 2017 FINANCIAL LITERACY CHAMPION OFFICIAL RULES

## NO PURCHASE, ACCOUNT OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE ODDS OF WINNING. VOID WHERE PROHIBITED.

**ELIGIBILITY**. The Financial Literacy Champion Contest (the "Contest") is open to individuals who are employed or volunteer on behalf of or are affiliated with a non-profit organization or school located in Wisconsin or Illinois and who will be 18 years of age as of April 1, 2017. All entrants must be legal residents of Wisconsin or Illinois and have the permission of the affiliated non-profit or school to participate. Multiple submissions per school or organization are allowed, but only one can be designated a Contest Finalist (defined below). Employees of First National Bank and Trust ("Sponsor"), members of such employees' immediate families and individuals living in the same household with such employees, are not eligible to enter or win the Contest. The Contest is void where the Contest, or the method of entry or any other aspect of the Contest, is prohibited or restricted by, or in violation of, law.

**CONTEST SUBMISSION PERIOD**. Contest submission will begin at 8:00:00 a.m. Central Standard Time ("CST") on April 3, 2017 and will end at 11:59:59 p.m. CST on April 24, 2017 (the "Contest Period"). Sponsor's time clock is the official clock for the Contest.

**HOW TO ENTER**. All interested schools, non-profit organizations, or individuals must submit an entry form at <a href="https://www.bankatfirstnational.com/flc">www.bankatfirstnational.com/flc</a> for the entry to be considered complete, however interested schools, organizations or individuals, may also submit additional supporting documentation to Sponsor at <a href="https://www.bankatfirstnational.com">FUN@bankatfirstnational.com</a> after completing the online submission form. Interested parties may also visit

<u>facebook.com/firstnationalbankandtrust</u> to submit an entry. After receipt of submission, entrants will receive an acknowledgement of receipt and copyright release form to be completed for official entry and consideration as a finalist.

By entering the Contest, entrants acknowledge and agree: (1) that they consent to their or their nominee's entry in the Contest, and (2) that their or their nominees entry submitted (including all additional supporting material embodied therein) shall automatically become the sole and exclusive property of Sponsor immediately upon submission.

SUBMISSION REQUIREMENTS. Multiple entries are allowed per school or non-profit, however, only one entry will be allowed for any individual. Submission of multiple entries by or on behalf of the same individual will result in ineligibility with respect to all entries by or on behalf of that entrant. Each submitted entry must be in English.

**GENERAL RULES**. The Financial Literacy Champion prize is \$100 and the school or non-profit organization affiliated with the winner will receive a prize of \$1,000.

**SELECTION OF WINNERS**. Following the Contest Period all entries will be reviewed for eligibility by a First National Bank committee. Up to 3 entries will be posted to facebook.com/firstnationalbankandtrust in the "FLC" Contest tab/application for final voting by the general public beginning Monday, April 24, 2017, 1:00 p.m. through Monday, May 8, 2017, 11:59:59 p.m. Individuals are able to vote once per person per day, and are required to like the First National Bank page on Facebook (<a href="https://www.facebook.com/FirstNationalBankandTrust">https://www.facebook.com/FirstNationalBankandTrust</a>) prior to voting. All votes will be verified and confirmed via Facebook ID. If Sponsor finds any form of voter fraud, entries will be disqualified. The Contest Finalist that receives the most votes will be the winner and shall receive the

Contest prize. The winner and their corresponding school or non-profit organization will be announced the week of May 9, 2017.

**HOW TO CLAIM PRIZES.** On or about May 9, 2017, Sponsor will notify via telephone and/or email the winning entry the information on how to collect their prize.

**PUBLICITY**. Unless prohibited by law, participation in the Contest constitutes each entrant's consent for Sponsor to use the entrant's name, age, photograph, image, likeness, statements and school or non-profit organization for Contest or other promotional, advertisement or commercial purposes in any media now known or later developed, without payment or consideration to the school, non-profit organization, entrant or any other person. **PRIVACY**. Sponsor will collect personal data from entrants when they enter this Contest, and this information will be used for the purposes of administering the Contest, publicizing the Contest and other promotional purposes that benefit Sponsor.

GENERAL CONDITIONS. By participating in this Contest, each entrant agrees to be bound by these Official Rules and the decisions or interpretation of Sponsor regarding the Official Rules, which are final and legally binding in all respects. **ADMINISTRATION AND INTERPRETATION.** Whenever Sponsor has the option, right or responsibility under these Official Rules to take any action or make any decision, judgment or determination, Sponsor reserves the right to do so (or decide not to do so) in its sole and absolute discretion, for any reason or no reason, without being required to explain or consider the consequences of its actions or the advice, opinions, perspective or rights of anyone else. This is necessary for the efficient operation of the Contest. Sponsor reserves the right to apply and interpret these Official Rules and conduct and administer the Contest. Any decision by Sponsor regarding the Contest, including eligibility of entrants and determination of the winners, shall be final and binding.

**RIGHT TO CANCEL OR MODIFY SWEEPSTAKES.** If the Contest is not capable of running as planned for any reason or cause which Sponsor deems could corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Contest, including fraud, technical failure, or insufficient participation, Sponsor reserves the right to cancel, terminate, modify or suspend the Contest or these Official Rules, including changing the Contest Period, or selecting a winner from entries received prior to the action taken or in such other manner as Sponsor may deem appropriate.
